




From the President

News from ASHA

There is a new device being created to assist people with hearing loss, and it's happening right here in Atlanta, Georgia! This new device enables people with hearing loss to have accessibility to view captions anywhere - from sport venues to classrooms to movie theaters. The director of the Landmarc Research Center at the Georgia Tech Research Institute (GTRI), Leanne West, is responsible for developing this wearable, wireless captioning system. West first decided to develop this product after speaking with colleagues ten years ago about lawsuits filed against movie chains by patrons with hearing loss. She said there "had to be an optical solution to provide captioning." A prototype is now being used at the Mystic Aquarium in Mystic, Connecticut where users view captions related to various exhibits. On January 3, 2010 during the Dallas Cowboys final regular season home game, DURATEQ **Assistive Technology Version** (ATV) handhelds were made available for fans that are deaf. hearing impaired, low vision or blind. The venue's transmitter sent captions to consumer's wireless-enabled personal digital assistant (PDA), smartphone, or laptop via standard wireless technology. Eyewear is also being developed that provides captioning - similar to that being used to watch movies on a personal DVD player. It is being customized for use at public venues. The wi-fi used to deliver the captions are already installed and in use in many facilities including coffee

shops, restaurants, and sports arenas. Consumers can view captions by downloading an inexpensive software application that is under development. A court reporter will provide the venue with pre-recorded captions or computer-assisted real-time translation (CART). After conducting a needs-assessment survev through the Georgia Council for the Hearing Impaired, West tested a prototype at a Hearing Loss Association of America conference where volunteers provided valuable feedback. West received funding to develop this technology through the GTRI and the National Institute on Disability and Rehabilitation Research. Along with West, GTRI research scientist Ethan Adler started a company called Intelligent Access to bring this product to market. West believes that this technology can assist people with hearing loss in a variety of settings. It can also transmit captioning or subtitles in multiple languages simultaneously. She believes that this device will eliminate the need for people with hearing loss to sit near a projection screen or near an interpreter. The system will be brought to market this vear.

It seems that SLPs are continuously faced with issues related to Medicare. Most recently, speechlanguage pathologists are now able to bill Medicare directly for laryngeal function studies. This is a product of two years of ASHA advocacy. This change appears in the 2010 annual update to the

therapy code list from the Centers for Medicare and Medicaid Services (CMS). It has added Current Procedural Terminology© (CPT) code 92520, "Laryngeal function studies (i.e., aerodynamic testing and acoustic testing)" to the therapy code list. From this update, it is reimbursable by Medicare and is also included as an expense under the speechlanguage/physical therapy cap. Also in recent Medicare news, President Obama signed legislation relating to an amended version of H.R. 4851, the Continuing Extension Act of 2010 into law. This amended version avoids the implementation of the 2010 Medicare Physician Fee Schedule (MPFS). This schedule includes a 21.3% reduction from the 2009 schedule on Medicare Part B payments. This new law is retroactive with an effective date of April 1. For Medicare contractors who have already begun processing claims based on the reduced rates of the 2010 MPFS. they will now be required to reprocess those claims to reflect current rates. In June, Congress will likely consider a more longterm solution to Medicare Part B reimbursement.



Armstrong Atlantic State University

The 2009-2010 academic year has been an eventful one for the communication sciences and disorders program! The fall semester got off to a great start as we happily welcomed our new class of 14 graduate students hailing from all over the United States. That number of students represented a 100% increase over our typical first year graduate class enrollment! Dr. Donna Brooks was appointed Assistant Dean of the College of Health Professions, and Dr. Stan Cooke took over the day to day operations of the program, serving as Interim Program Coordinator.

Midway through the spring semester, AASU administrators announced that several clinical health programs, including communication sciences and disorders, might be discontinued due to Georgia's expected budget shortfalls for the coming fiscal vear. Following this announcement, students, clients and their families, and other community stakeholders mobilized and advocated at all levels -- from the administration at AASU to the Board of Regents to the General Assembly -- for the continuation

of the program. ASHA and GSHA also wrote letters of support. In May 2010, AASU administrators announced that the program in communication sciences and disorders would not be eliminated as had been proposed. Instead, the program is still going strong!

Seven students received the Master of Science in communication sciences and disorders at Spring Commencement, and will be beginning clinical fellowships. We will welcome another cohort of 16 new graduate students in August, in addition to our growing numbers of students in the undergraduate major. We bid a fond farewell and sincere thank vou to Dr. Cooke as he continues his retirement, and we welcome Dr. Brooks back as Program Coordinator while she continues to serve as Assistant Dean of the College.

Georgia State University

Spring semester was a productive time at Georgia State University! We interviewed 85 applicants to our master's degree program and are looking forward to fall semester when a cohort of 19 new students will begin the program. Congratulations to our most recent graduate (May, 2010) Meredith Avren. Faculty and students received a number of awards this past semester. At the GSHA Convention in March, Dr. Debra Schober-Peterson received the Volunteer Appreciation Award, Ms. Mary Rambow received the Clinical Achievement Award, and Dr. Colleen O'Rourke received the Robert A. Hull Leadership Award. At the College of Education Honors Day the following students

received awards: Anna Sheppard, Outstanding Master's Student in Special Education; Amy Glasco, Outstanding Clinician in Communication Disorders; and Brittany Carroll, Andrea Davis, Carrie Forde, Elizabeth Omaivboje, and Janet Williams all were awarded the Glenn A. Vergason Scholarship. Graduate student Michaela DuBay also received a NIDCD Fellowship to present her thesis work at the 2010 Clinical Aphasiology Conference in South Carolina in May. Her thesis work is under the direction of Dr. Jacqueline Laures-Gore and investigates coping resources in individuals with aphasia. We are proud of our faculty and student accomplishments!

The Georgia State NSSLHA chapter hosted a successful job fair in February. Eight vendors including school districts and contract rehabilitation companies were actively recruiting for speechlanguage pathologists. Students from Georgia State, the University of Georgia, and Auburn University attended. Our NSSLHA chapter plans to make the job fair an annual event so watch for announcements about the date of the 2011 fair. NSSLHA members also participated in Autism Walks in May raising money for this important cause. New chapter officers were elected in April and are excited about the year ahead.

Georgia State successfully celebrated our Twelfth Annual Summer Institute on June 24-25. Dr. Geralyn Timler from Miami University of Ohio, a specialist in child language, presented





Reception for Senator Moody

A reception was hosted by Georgia Speech-Language Hearing Association (GSHA) members and lobbyists, Stan Jones and Helen Sloat, in honor of Senator Dan Moody at the offices of Nelson Mullins Riley & Scarborough in Atlanta, Georgia on June 16th. Senator Moody was presented with the **GSHA Legislator Appreciation Award** with members and lobbyists from both GSHA and the Georgia Occupational Therapy Association (GOTA) present. Senator Moody was nominated for this award by members of the Healthcare Committee due to his tireless efforts to enable children with speech, language, hearing, and swallowing disorders to receive the therapy that is needed to improve their quality of life. Senator Moody has worked with the tri-alliance regarding system wide Medicaid problems which are causing therapists undue hardship and are preventing children with disabilities from getting the therapy services they require. He sponsored Senate Bill 507 the intent of which was to require Medicaid and the CMO's to grant prior authorizations for 6 months of therapy at one time to children with chronic conditions in addition to several other issues. He also hosted several meetings with the Department of Community Health, the medical directors of the CMO's, and tri-alliance members to work out ongoing Medicaid problems. Overall, he has been a champion for children with disabilities and the therapists that serve these children.

Senator Moody is retiring from the Georgia Senate. When asked what he would recommend regarding the continuing efforts of therapists to get problems resolved, he indicated that therapists should meet with their local legislators throughout the year to make them aware of SLP issues so that when these issues come up in the legislature they will be educated about them. The tri-alliance has enjoyed working with Senator Moody, and we wish him the best with his retirement.
